Observe & film police in public or on your private property
Ask police for name & badge numbers
Question police actions

DO NOT:

Physically interfere with police Enter a designated crime scene Touch a police officer at any time

Film as close to the scene as you are comfortable doing. Police may ask you to step back or stand elsewhere. You may take a step back if you'd like, but there is no legally required distance. Just make sure you're not blocking the road or sidewalk.

If threatened with arrest, clearly state, "I am not physically interfering." Speech is not interfering.

NEVER CONSENT TO A SEARCH

Police may ask, "You don't mind if I look in your [car, purse, trunk, backpack, etc.], do you?"
Say, "I do not consent to any searches."
Police need a search warrant to enter your home or to search your car or your person.

If they have a warrant, verify the address and/or content to be searched.

For a vehicle stop, you must provide your license and registration. Nothing more is required.

REMEMBER THESE KEY PHRASES

"Am I being detained or am I free to go?"

"I do not consent to any searches."

"I am asserting my right to remain silent."

"I would like to speak with an attorney."
